Special Instructions _____

Some pets can get a bit stressed by the change in their routine, their environment, and their diet, and may have a day or two of loose stool while away from home. We feed a bland rice and bouillon diet on these occasions. If loose stool persists, however, we will give the pet Kaopectate, Pepto, or Endosorb Tablets.

1. This is an Agreement between Littleton Pet Center and the pet owner whose signature appears below (hereinafter called "Owner").
2. Owner agrees to pay the rate for pet care provided in effect on the date pet is checked into Littleton Pet Center and to pay all costs and charges for special service requested.
3. Owner agrees that all checks are deposited the day they are received. A service charge of \$25 will be assessed when checks fail to clear the bank on which drawn.
4. **Deposit Policy:** Littleton Pet Center requires a 50% NON-REFUNDABLE deposit for all Holidays and Vacations periods. The deposit will go towards the boarding stay, however it is NON-REFUNDABLE if Pet is a NO-SHOW or the reservation is not cancelled by 8 AM on the day prior scheduled arrival date. Please understand that space in our facility is in high demand, and that we strictly follow our cancellation policy.
5. Littleton Pet Center shall exercise reasonable care for the pet delivered by the Owner to the pet care provider. If interactive daycare is provided, Owner recognizes and accepts potential risks involved in such activity. It is expressly agreed by Owner and pet care provider that Littleton Pet Center's liability shall in no event exceed the lesser of the current chattel value of a pet of the same species per animal admitted. The Owner further agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of the pet care provider, to include payment of costs for injury to staff or other animals or damage to facilities caused by the pet.
6. All charges incurred by Owner shall be payable upon pick-up of pet, or when billed by Littleton Pet Center and Facility at address listed on contract. Littleton Pet Center shall have, and is hereby granted, a lien on the pet for any and all unpaid charges resulting from services provided by Littleton Pet Center. The Owner hereby agrees that in the event the charges are not paid when due in accordance with this contract, Littleton Pet Center may exercise its lien rights upon ten days written notice given by Littleton Pet Center to Owner by certified mail to address show on contract. Littleton Pet Center may dispose of pet for any and all unpaid charges, at private or public sale, in the sole discretion of Littleton Pet Center, and Owner specifically waives all statutory or legal rights to the contrary. If such a sale shall not secure a price adequate to pay such costs of pet care or other charges delinquent, plus cost of sale, then Owner shall be liable to Littleton Pet Center for the difference. All monies realized by Littleton Pet Center at such sale, over and above the charges due and costs of sale, shall be paid to Owner.

7. If pet becomes ill or injured, or if the state of the animal's health otherwise requires professional attention, Littleton Pet Center, in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the animal, and the expenses thereof shall be paid by the owner.
8. This Agreement contains the entire agreement between parties. All terms and conditions of this Agreement shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and Littleton Pet Center.
9. Any controversy or claim arising out of or relating to this Agreement, or the breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this Agreement, shall be settled in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by an arbitrator may be entered in any Court having jurisdiction thereof. The arbitrator shall, as part of the award, determine an award to the prevailing party of the costs as such arbitration and reasonable attorney's fees of the prevailing party.
10. Owner specifically represents to Littleton Pet Center that, to the Owner's knowledge, the pet has not been exposed to any contagious diseases within a thirty-day period prior to check-in. During the period of this Agreement, Owner also agrees to notify Littleton Pet Center of any known exposure of pet to a communicable disease and hold pet out of attending Littleton Pet Center and until pet is symptom-free for a minimum of 14 days or with a veterinary clearance. Owner further agrees to maintain currency of vaccinations as required by Littleton Pet Center policy.
11. Owner specifically represents that he or she is the sole owner of the pet, free and clear of all liens and encumbrances.
12. By signing this Agreement and leaving pet with Littleton Pet Center, Owner certifies to the accuracy of all information given about said pet. Littleton Pet Center reserves the right to deny admittance to Owner's pet for any reason at any time.
